Guided by his extensive experience working with victims and those accused of crimes, and informed by social science and data, he has built a culture of innovation, embracing groundbreaking new initiatives to improve public safety and strengthen community trust. This approach seeks to reduce prosecutors' reliance on incarceration while seeking accountability, preventing recidivism, and addressing the root causes of crime.

DA Gonzalez grew up in East New York and Williamsburg, Brooklyn. He is a graduate of John Dewey High School in Coney Island, Cornell University, and the University of Michigan Law School. He lives in Brooklyn with his wife and three sons.
