TENANT JUSTICE PANEL EVENT RECAP

Last Wednesday's event was organized by Brooklyn Law School Housing Justice Clinic student-attorneys Dario Arroyo, Kayla Richards, and Keyana Griffith, who coordinated and led the program.

Kayla opened the event with introductory remarks and facilitated audience participation. Professor Aissatou Barry then provided grounding context on rent-stabilized housing in New York City, touching on deteriorating conditions in rent-stabilized units, challenges in enforcing the Warranty of Habitability, and the impact of intentional displacement.

The panel, featuring Adam Markovics (Bronx Defenders), Kelsey Feehan (Communities Resist), and Michael Rowley (CAMBA), offered a thoughtful look at tenant-side advocacy, systemic barriers tenants face, and the realities of housing justice work across the city. Panelists also shared practical insights for students interested in this area of practice, with discussion co-moderated by Kayla and Keyana.

Pro Bono Opportunity UNCONTESTED DIVORCE CLINIC

In collaboration with the NYS Office for Justice Initiatives, the City Bar Justice Center's (CBJC) Uncontested Divorce Clinic offers free legal help to individuals navigating the divorce process without an attorney.

The clinic occurs in person every Tuesday and Wednesday from 9:30am-12:30pm at Kings County Supreme Court. Under CBJC supervision, students will meet with pro se litigants to gather relevant case information and assist with preparing and filing uncontested divorce forms.

The clinic is seeking students who are available to volunteer at least two Tuesdays per month for the semester. A recorded training will be available for interested volunteers. Students will also receive training on the software required to successfully file documents for an uncontested divorce.

New York State Excelsior Service Fellowship Program

Excelsior Service Fellows work full time at host executive-branch agencies and authorities, advancing the operational and legal aspects of important policy initiatives. Fellows will also participate in a Professional Development program focusing on leadership development and the fundamentals of New York State government. After completing the Excelsior Service Fellowship Program, exceptional fellows may continue to serve New York State. More than 60% of prior classes of Excelsior Fellows were offered permanent positions with the State post-fellowship.



Program Requirements

- Candidates must have earned their graduate degree (i.e., MPA, MA, MBA) or an advanced degree (i.e., JD, PhD) in the 2025-26 academic year. Generally, this means August 2025–May/June 2026.
- Candidates must be eligible to work for New York State without employer sponsorship.



Fellowship Placements

Candidates are encouraged to note their areas of interest and any preferred placement agencies; however final placements will be dictated by budget and the needs of state government. Law school graduates will be placed in legal assignments unless they expressly request otherwise. While some opportunities exist in New York City and elsewhere in the state, most agency placements are located in Albany. Sample placements include:

Application Process

Applications and nominations for the 2026 New York State Excelsior Service Fellowship Program will be administered by participating partner schools. **Interested applicants should submit the following materials in a single pdf through Symplicity #78918 by February 7:** resumé, transcript, personal statement, and two references/letters of recommendation.

Fellowship Program Goals

The Health Law Section of the New York State Bar Association is pleased to announce the 2026 Diversity Summer Fellowship in Health Law. The Diversity Summer Fellowship in Health Law is part of the New York State Bar Association's Diversity Challenge to develop and execute initiatives to increase the diversity of its membership, leadership, and programs. The primary goal of the Fellowship is to increase representation of lawyers and students from a diverse range of backgrounds in health law and provide students from a diverse range of backgrounds an opportunity to experience health law practice.

Eligibility

The Fellowship is open to all students as of the Fall 2025 semester who are enrolled in a law school in the State of New York, who intend to practice law in New York State upon graduation, and who are capable of fulfilling the requested work hours and responsibilities. Fellowship finalists may be interviewed in person or virtually.

The Fellowship

The Fellowship will be awarded as follows:

The Diversity Summer Fellowship in Health Law plans to place a law student in an 8-week summer fellowship with a healthcare attorney or facility across New York State, including but not limited to Albany, New York City, Long Island and Westchester.

- 8-week fellowship
- Placement with a health law attorney in the healthcare industry
- \$ 6,000 Stipend
- Luncheon with healthcare leaders and attorneys

The Fellow will be a guest member of the NYSBA Health Law Section for one year starting with the award of the Fellowship.


- The Fellow will be invited to attend Executive Committee meetings of the NYSBA Health Law Section during the fall meeting.
