

The Sparer Fellowship offers \$6,500 summer stipends to BLS students who intern in public interest law.

The Edward V. Sparer Public Interest Law Fellowship prepares lawyers to work for social justice. The core component of the Sparer Fellowship Program is a 8-10 week paid summer internship with a public interest organization in the U.S. or abroad. Fellows also attend monthly luncheons that highlight current public interest issues, and help plan academic events. Throughout their law school years and beyond, fellows are mentored by faculty experts who teach courses and have rich backgrounds in this area of the law, as well as leading professionals and distinguished alumni fellows practicing in this area.



### **New York State Excelsior Service Fellowship Program**

Excelsior Service Fellows work full time at host executive-branch agencies and authorities, advancing the operational and legal aspects of important policy initiatives. Fellows will also participate in a Professional Development program focusing on leadership development and the fundamentals of New York State government. After completing the Excelsior Service Fellowship Program, exceptional fellows may continue to serve New York State. More than 60% of prior classes of Excelsior Fellows were offered permanent positions with the State post-fellowship.



#### **Program Requirements**

- Candidates must have earned their graduate degree (i.e., MPA, MA, MBA) or an advanced degree (i.e., JD, PhD) in the 2025-26 academic year. Generally, this means August 2025–May/June 2026.
- Candidates must be eligible to work for New York State without employer sponsorship.



#### **Fellowship Placements**

Candidates are encouraged to note their areas of interest and any preferred placement agencies; however final placements will be dictated by budget and the needs of state government. Law school graduates will be placed in legal assignments unless they expressly request otherwise. While some opportunities exist in New York City and elsewhere in the state, most agency placements are located in Albany. Sample placements include:

- Empire State Development
- Office of Children & Family Services
- Department of Health

#### **Fellowship Program Goals**

The Health Law Section of the New York State Bar Association is pleased to announce the 2026 Diversity Summer Fellowship in Health Law. The Diversity Summer Fellowship in Health Law is part of the New York State Bar Association's Diversity Challenge to develop and execute initiatives to increase the diversity of its membership, leadership, and programs. The primary goal of the Fellowship is to increase representation of lawyers and students from a diverse range of backgrounds in health law and provide students from a diverse range of backgrounds an opportunity to experience health law practice.

#### Eligibility

The Fellowship is open to all students as of the Fall 2025 semester who are enrolled in a law school in the State of New York, who intend to practice law in New York State upon graduation, and who are capable of fulfilling the requested work hours and responsibilities. Fellowship finalists may be interviewed in person or virtually.

#### The Fellowship

The Fellowship will be awarded as follows:

The Diversity Summer Fellowship in Health Law plans to place a law student in an 8-week summer fellowship with a healthcare attorney or facility across New York State, including but not limited to Albany, New York City, Long Island and Westchester.

- 8-week fellowship
- Placement with a health law attorney in the healthcare industry
- \$ 6,000 Stipend
- Luncheon with healthcare leaders and attorneys

The Fellow will be a guest member of the NYSBA Health Law Section for one year starting with the award of the Fellowship.

- The Fellow will be invited to attend Executive Committee meetings of the NYSBA Health Law Section during the fall meeting.
- 2. The Fellowship recipient will be announced in January 2026.
